Because each person is unique, we will first complete a care needs assessment which is then used to calculate the cost of care using our person centered pricing worksheet. Listed below are generalized descriptions of care levels for purposes of creating a starting point for conversation:

Assisted Living – Self Care defined: This person is semi-independent and able to understand and act accordingly with most verbal communication by staff and other providers. He or she will also be able to communicate needs and wants to staff verbally most of the time. Capable of walking and transferring independently (may include the use of a walker). Capable of eating, dressing, grooming, bathing, toileting with supervision (does not require assistance). Has full control of bladder and bowel functions.

Assisted Living – Total Care defined: This person is dependent on others for care and to oversee their personal safety. He or she will be capable of walking with assistance and/or uses a wheelchair independently (or with assistance). Requires assistance with two or more ADL's (eating, bathing, dressing, toileting, transferring and walking, continence). Requires staff assistance and supplies to manage incontinence of bladder or bowel or both. Requires occasional reassurance and/or redirection (verbal) by staff due to moderate confusion, disorientation, anxiety and/or agitation.

Memory Care defined: This person is dependent on others for care and to oversee their personal safety (up to and including exit doors that are alarmed and/or locked). He or she will require assistance with two or more ADL's (eating, bathing, dressing, toileting, transferring and walking, continence). Requires staff assistance and supplies to manage incontinence of bladder or bowel or both. Requires frequent redirection and/or intervention (hands-on or limited 1:1 assistance) by staff due to ongoing confusion, disorientation, anxiety, agitation, refuses care, refuses medications, sundowning syndrome, exit seeking and other disruptive/repetitive behaviors.
